5. Fire Fighting Measures

Extinguishing Media Recommended:	Use CO2, Dry Powder or Foam Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.
Special Measures	Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear protective self contained breathing apparatus & protective clothing.
Extinguishing Procedures	Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

Personal precautions:	Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillage
Environmental precautions: Cleaning up methods for spillages:	Keep away from drains, soils, surface & ground waters. Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal and local disposal regulations

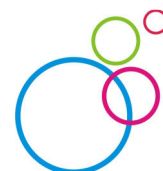
