### 4. Hazards Identification

Inhallation: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

## 5. Fire Fighting Measures

Extinguishing Media Recommended:	Use CO2, Dry Powder or Foam Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.
Special Measures:	Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.
Extinguishing Procedures:	Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

Cleaning up methods for spillages:	Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe local disposal regulations.
