4. First Aid Measures

5. Fire Fighting Measures

Extinguishing Media Recommended:	Use CO ₂ , Dry Powder or Foam Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.
Special Measures:	Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self contained breathing apparatus & protective clothing.
