## 4. First Aid Measures

## 5. Fire Fighting Measures

Environmental precautions: Cleaning up methods for spillages	Keep away from drains, soils, surface & ground waters.  Remove all potential ignition sources. Contain spilled material. Cover with an inert or non combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe local disposal regulations.
